Petition under Article 226 Constitution of India praying that in the circumstances stated in the affidavit filed in this petition, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the proceedings in Ref.. No.E6/534/2020 dt.0422-04-2020 of the 4th respondent in changing the Classification of the land in Sy.No.14/C1 extent Ac.1.05 cents from DPW Bangaiow Poramboke to Assessed Waste situated in Anantapuram village, Chapadu mandal for the purpose of grant of house sites is unconstitutional, arbitrary, illegal and violation of Art.51(i) and orders of the Honble Apex court reported in 2011(11) SCC 396 (Between Jagapal Singh and Others Vs State of Punjab and Others) and further direct the respondents to preserve the land in Sy.No.14/C1 extent Ac.1.05 cents from DPW Bangaiow Poramboke situated in Anantapuram village, Chapadu mandal as existing prior to the impugned orders for community use.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the Writ (PIL) petition, the High Court may be pleased to suspend the operation of impugned proceedings in Ref. No.E6/534/2020, dt 22-04-2020 of the 4<sup>th</sup> respondent in changing the Classification of the land in Sy. No.14/C1 extent Ac. 1.05. cents from "DPV" Bangalow Poramboke to Assessed Waste" situated in Ananthapuram Village Chapadu Mandal pending and consequential action of the authorities in making the layout over the subject land for distribution of house sites, , pending disposal of WP(PIL) 106 of 2020, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri G Seena Kumar Advocate for the Petitioner, GP for General Administration for Respondent No.1 and of GP for Revenue for Respondent Nos.2 and 4 to 6 and of GP for Panchayat Raj for Respondent No.3, the Court made the following.

**ORDER**

**Learned Government Pleader for Revenue seeks two weeks time to file detailed counter.**

The subject land shall not be allotted as house sites, pending further orders.
