**ORDER:**

In compliance with the orders of the Hon'ble Supreme Court of India, in the first read above and as per the proposal of the Registrar (Administration), High Court of Andhra Pradesh in the second read above, Government hereby, accord to sanction Eight (8) Special Courts in the Districts of Chittoor, East Godavari, Guntur, Krishna, SPS Nellore, Prakasam, Visakhapatnam and West Godavari where more than 100 cases under the POCSO Act are pending. The Courts shall have jurisdiction for entire district for trial of offences under the Protection of Children from Sexual Offences Act, 2012 with the following Staff pattern and expenditure sanctioned for each Court is as specified below, respectively :
