2. Resolution of the Bar Council of A.P. with regard to levy & collect such fees from a Law Graduate for any GAP period in their academics is here below extracted.

Resolution :

"After considering the enrolment fee being collected by different State Bar Councils and also in view of the expenditure being incurred in enrolment process, it is resolved to enhance the enrolment fee with effect from 01-01-2017 as shown below:

General category	- Rs.10,000/-
S.C. & S.T.	- Rs. 8,000/-
Gap	- Rs. 700/- per year
Service Candidates	- Rs.25,000/-

The above fee is inclusive of all payments payable by the candidates."

3. No. of Law graduates applied for enrolment on 17-03-2022 are "525"
4. No. of Law graduates who had GAP period in their academics on 17-03-2022 are "45"
5. Total amount collected from the applicants who has GAP period on 17-03-2022 is Rs.15,87,000/-


