#### **CONTENTS OF WRIT PETITION (PIL)**

# I. <u>Particulars of the cause/order against which the</u> petition is made:

The writ petition is being filed in public interest aggrieved by the inaction of the Respondents in issuing a Gazette Notification regarding the usage of A4 size paper (Double Side) at all District Courts in State of Andhra Pradesh. It is frustrating to note that many Constitutional Courts including this Hon'ble Court have started using

A4 size paper (Double Side) but the same benefit is not yet extended to the District Courts in the State of Andhra Pradesh, just because the Respondents have not issued the necessary Gazette Notification for enforcement.

#### **II.** Particulars of the Petitioner:

A brief profile of the Petitioner is as follows:

1. The Petitioner herein is a practicing advocate (AP/646/2022) and filed this Public Interest Litigation representing the cause as a public spirited individual and concerned with the travesty of the general public litigants at District Court in Andhra Pradesh, who are burdened to use Legal size paper.

#### 2. Locus Standi:

The Present Petition is being filed by way of Public Interest Litigation (PIL) and the Petitioner does not have any personal interest in the matter. This Petition is filed in the larger interest of the people litigating before the District Courts in State of Andhra Pradesh. Therefore, this Hon'ble court has got both territorial and pecuniary Jurisdiction to entertain the above PIL under the Public Interest Litigation Rules, 2015, since cause of action arose in the State of Andhra Pradesh, which is well within the Jurisdiction of this Hon'ble Court. As a practicing advocate, Petitioner herein has Locus to file this PIL. There is no other personal interest for the Petitioner in this instant writ petition.

#### **III.** Declaration and understanding of the Petitioner:

I, Sandeep Pamarati, aged 41, S/o Pamarathi Veerabhadra Rao, the Petitioner, am a native of Anantapur District and am currently residing at Mangalagiri, for his advocacy practice before this Hon'ble High Court.

The Petitioner herein declares and undertakes:

- i. That the present Petition is being filed by way of a public Interest Litigation in the larger interest of the general public and the Petitioner does not have any personal interest in this matter. The Petitioner is well acquainted with the facts and circumstances of the case.
- i. The entire litigation costs, including the advocate's fee and other charges are being borne by the Petitioner from his personal expenditure.
- ii. That thorough research has been conducted in the matter raised through the Petition using Representation and RTI applications to High Court of AP and to the Home Department of State of AP.
- iii. That to the best of the Petitioner's knowledge and research, the issue raised has not been dealt with or decided and that a similar or identical petition has not been filed earlier by the Petitioner before a court of law.
- iv. That the Petitioner has understood that in the course of hearing of this petition the Court may require any security to be furnished towards costs or any other charges and the Petitioner shall have to comply with such requirements.
- v. That the Petitioner has never faced contempt of court proceedings.

- vi. That the Petitioner has never been ordered by any Hon'ble Court not to file any further PIL cases.
- vii. The Petitioner is primarily relying on the provisions of Constitution and State laws. The Petitioner is also relying on Circulars passed by the Hon'ble Apex Court regarding the usage of A4 size paper (Double Side) at all District Courts in State of Andhra Pradesh.

#### IV <u>Facts in brief, constituting the cause:</u>

#### **Source of Information:**

It is submitted that the information of the facts used in this Petition is replies received from the Registry of this Hon'ble Court and from the Home Department of State of AP to the Representation and RTI applications filed. Both these data are received from original sources and hence the Petitioner did not verify the data himself and believes that the data is authentic.

#### V. <u>Nature and Injury Caused/apprehended:</u>

- That the Hon'ble Apex Court passed a Circular dt: 05-Mar-2020 regarding the usage of A4 size paper (Double Side) with printing on both sides. A copy of the Circular is annexed as **ANNEXURE-P1**. The Hon'ble Apex Court clearly gave reasons for making such move.
- 2. That this Hon'ble Court had passed a Circular No.12/2022 dt: 29-Jul-2022 under ROC No.426/SO/2021, a copy of which is annexed as **ANNEXURE-P2**. This Circular notified instructions to use A4

- size paper (Double Side) only, for all types of cases and other documents, with effective date of 01-Sep-2022. It is pertinent to note that, this Circular is restricted only to this Hon'ble Court but was not extend to the District Courts of Andhra Pradesh.
- 3. That during the time period from 01-Sep-2022 onwards, there was no Circular from this Hon'ble Court extending A4 size paper (Double Side) usage to District Courts in the State.
- 4. That the Petitioner was not aware of the reasons for not passing necessary Circulars applicable to District Courts in the State. Hence the Petitioner sent a Representation to Hon'ble The Registrar (Judicial), High Court of Andhra Pradesh through a letter dt: 18-Mar-2023 with a prayer,

"to consider and appropriate directions be issued by the competent authority to permit usage of A4 size paper (both sides) at District Courts also".

A copy of the Representation is annexed as **ANNEXURE-P3.** 

5. That the petitioner received a reply from the office of Hon'ble Registrar General dt: 28-Mar-2023 informing as follows:

"the issue with regard to usage of A4 paper size in District Courts has been considered and necessary amendments have been made to Criminal Rules of Practice & Circular Orders, 1990, Civil Rules of Practice & Circular Orders, 1990, Writ Proceeding Rules 1977 and the Appellate side Rules by the High Court of Andhra

# Pradesh, and the same is now pending with the Government for issuance of Gazette Notification."

A copy of Reply to Representation is annexed **ANNEXURE-P4**.

- 6. That the petitioner sent a RTI application to the Principal Secretary, Department of Home Affairs, Government of Andhra Pradesh dt: 26-May-2023. The following are the questions for which information was sought. A copy of RTI application is annexed ANNEXURE-P5.
  - 1. Have you received any communication from Registry, AP High Court, seeking your department to issue a Gazette Notification to this effect, on usage of A4 size paper in all proceedings in all District Courts in Andhra Pradesh?
  - 2. When have you received this communication?
  - 3. Is any Gazette Notification published by your department to this effect, on usage of A4 size paper in all proceedings in all District Courts in Andhra Pradesh?
  - 4. Can you please point me to the location of the Gazette Notification on the official website of your department?
  - 5. Can you please share a soft copy of the Gazette Notification to me on my email ID: Sandeep.pamarati@gmail.com?
  - 6. Can you please point me to the official websites of the Home Department and Law Department of Government of Andhra Pradesh?
- 7. That the Petitioner received a reply on dt: 06-Jun-2023 from Assistant Secretary to Government, Home (Courts. B) Department, AP Secretariat, informing that the RTI application is transferred to PIO, Registrar General, High Court of AP for taking further taking necessary action. A copy of Reply to the RTI application is annexed **ANNEXURE-P6**.
- 8. That, after more than 1 month, the Petitioner received a reply to the RTI application on 10-Jul-2023, from Registrar Judicial, High Court of AP, clearly informing the Petitioner that Registrar General High Court of AP has furnished to the Registrar Judicial, that the

questions raised in the RTI application dt: 26-May-2023 are 'to be answered by the State Government' concluding that there is no action pending before the Hon'ble Registry, High Court of AP. A copy of Reply to RTI application dt: 26-May-2023 received from Registrar Judicial, High Court of AP is annexed ANNEXURE-P7.

- 9. That the Respondent has not furnished any further communication to the Petitioner on the subject matter of issuing a Gazette Notification regarding allowing usage of A4 size paper (Double Side) in all District Courts of AP.
- 10. That the Petitioner is aggrieved by the inaction of the Respondent in not issuing a Gazette Notification regarding allowing usage of A4 size paper (Double Side) in all District Courts of AP.

#### **VI** Representations:

It is respectfully submitted that the Petitioner sent a RTI application to Respondent herein, with a prayer seeking copy of Gazette Notification issued for usage of A4 paper size in District Courts. Thus, the Petitioner having left with no other alternative is approaching this Hon'ble Court. The Petitioner has not sent any other representations to Respondent.

#### **VII.** Delay, if any, In filing the Petition and Explanation:

It is submitted that there is no delay in filing this instant PIL, as this is a continuous cause of action from the date of inaction of the Respondent in not issuing a Gazette Notification regarding allowing usage of A4 size paper (Double Side) in all District Courts of AP. Therefore, in the event of this Hon'ble court coming to a conclusion that there is any delay in approaching this Hon'ble Court, the same may be condoned, keeping the large public interest in the instant matter.

Aggrieved by the inaction of the Respondent in not issuing a Gazette Notification regarding allowing usage of A4 size paper (Double Side) in all District Courts of AP, the Petitioner has no other alternative and effective remedy except to approach this Hon'ble Court under Articles 226 of the Constitution of India.

The Petitioner has not filed any other writ or proceedings before any other Court or Authority praying for the same relief sought for in this writ petition with respect to the State of Andhra Pradesh.

#### **VIII.** Material relied upon:

The Petitioner relied on the Circulars issued by Hon'ble Supreme court and Hon'ble High Court of AP and Representation and RTI Applications sent to the Respondent and the Registry of the High Court of AP, all of which are annexed to this writ petition (PIL).
