NOTIFICATION-II

2. In exercise of the powers conferred by Sub-Section of section 8B of Dowry Prohibition Act, 1961 (Act 28 of 1961), the Government of Andhra Pradesh hereby confer the following powers of the Police Officers on the Revenue Divisional Officer/Sub-Collector/Assistant Collector in charge of Revenue Division in discharge of their duties as Dowry Prohibition Officers, namely:-

- (i) Power to Register cases;
- (ii) Power to examine the witnesses;
- (iii) Power to investigate cognizable offences;
- (iv) Power to arrest, if prima facie case is made out;
- (v) Power to send the accused to remand within 24 hours.
- (vi) Power to search and seizure, if any incriminating material concerning the offence is forthcoming;
