1. My application vide **TSRTI/APP/HOM/26/07/25/DI/15205** for information under RTI Act, 2005 dated **26/07/2025** addressed to PIO of Home Department(Prosecutions) establishment.
2. My First Appeal application vide **TSRTI/FAA/HOM/25/08/25/DI/4274** for information under RTI Act, 2005 dated **25-08-2025** addressed to FAA of Home Department(Prosecutions) establishment.

Respected Sir,

The undersigned hereby submit an appeal application with the following details as per prescribed rules.

1. My **RTI application** vide **TSRTI/APP/HOM/26/07/25/DI/15205** for information under RTI Act, 2005 dated **26-07-2025** addressed to PIO of Home Department(Prosecutions) establishment was not responded to within the statutory time limit of 30 days therefore it was deemed refused by the Telangana RTI portal on **25-08-2025**. Annexed the print out of the entire **RTI Original application** with relevant data fields from the Telangana RTI portal.

2. After my RTI application was held to be deemed refused, I filed my **First Appeal** application via the Telangana RTI portal vide **TSRTI/FAA/HOM/25/08/25/DI/4274** for information under RTI Act, 2005 dated **25-08-2025** addressed to FAA of Home Department (Prosecutions) establishment, which too was not responded to within the statutory time limit therefore it too was deemed refused by the Telangana RTI portal on **07-10-2025**. Annexed the print out of the entire RTI **First Appeal** application with relevant data fields from the Telangana RTI portal.

3. Hence this **Second Appeal** to the office of the Hon'ble State Information Commission, seeking direction to the PIO and FAA to provide me the information sought in my original RTI application vide **TSRTI/APP/HOM/26/07/25/DI/15205**

4. Brief facts leading to appeal:

I sought G.O.s pertaining to the implementation of mandate prescribed under Section 8B of the Dowry Prohibition Act 1961, with respect to appointment of Dowry Prohibition Officers in the State of Telangana.

5. Prayer / Relief sought:

I sought G.O.s pertaining to the implementation of mandate prescribed under Section 8B of the Dowry Prohibition Act 1961, with respect to appointment of Dowry Prohibition Officers in the State of Telangana.

6. Appeal grounds for the prayer / relief :

No response from either the Public Information Officer or from the First Information Officer, neither within the statutory time limit nor even till date.

7. Since the date of deemed refusal of my RTI Appeal was on **07-10-2025**, I submit that my instant Second Appeal u/s 19(3) of RTI Act, 2005 is well within the statutory time limit of 90 days, as on today.
